### Entry

- 2 Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. #### **General**

- 24 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant).
